ABOUT THE POSITION

We are looking for **two** student interns for a six months' internship starting **January 26th, 2022**.

The Business and Human Rights internship focuses on analysis and business consulting on CSR and Human Rights. You will be working on several projects, getting a solid insight into the principles-based approach to CSR, with particular attention to Social Sustainability. We work in an open office, where you will be in close contact with other consultants, providing you with opportunities to work with and learn from experts in the field.
